One hundred percent (100%) Labor, Material and Performance Bond and a Certificate of Insurance will be required of the successful bidder.

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without the written consent of the OWNER. The OWNER will notify the successful bidder within sixty (60) days after receiving bids.
