

TRUCK DRIVER—STREETS AND SANITATION (DIVISION 2)

THE OPPORTUNITY

The City of St. Joseph is looking for a qualified candidate to operate the rubbish truck and perform a broad range of manual labor and semi-skilled tasks involved with the operation of the Public Works Department.

SUPERVISION RECEIVED

Works under the direction of the Streets and Sanitation Superintendent or Foreman.

SUPERVISION EXERCISED

May oversee seasonal or temporary employees, as assigned.

RESPONSIBILITIES

An employee in this position may be called upon to do any or all of the following essential duties: (These examples do not include all of the duties which the employee may be expected to perform.)

- Operate heavy dump trucks, typically involved in snow plowing and removal, rubbish, brush and leaf removal, or the transport of other material. Oversee seasonal or temporary staff, if assigned.
- Operate rubbish truck. Make certain rubbish is collected in accordance with department policies. Assist in loading rubbish as necessary.
- Operate vac-all truck, leaf vac truck, and other equipment used in leaf, or brush removal.
- Perform unskilled or semi-skilled tasks related to rubbish collection. Place rubbish in rubbish truck compactor and operate compactor.
- Perform unskilled or semi-skilled tasks related to street maintenance, including; storm sewer maintenance; pothole repair; pavement marking; set up and take down temporary barricades or signs; and traffic control.
- Concrete maintenance and repair, including concrete cutting, grinding, and replacement.
- Operates pickup trucks, light-duty dump trucks, and other equipment not requiring specialized licenses or training.
- Assists senior or more skilled employees performing skilled tasks.
- Performs routine preventive maintenance tasks such as checking filters and fluid levels for gas and diesel-powered vehicles, hydraulic systems, small engines, and equipment as assigned.
- Adheres to established safety policies and procedures and participates in safety instruction and programming.
- Accurately records activity, labor, and equipment time on time cards, in keeping with departmental policies. Records information related to vehicle usage, equipment, maintenance, work assignments and other activities.
- Performs related work as required.

PREFERRED SKILLS AND QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and ability (KSA's) required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Knowledge of and ability to operate common tools and equipment used in the repair and maintenance of buildings, equipment, streets and grounds, including but not limited to air compressors, jackhammers, concrete saws, pressure washers, and chainsaws.
- Ability to operate equipment needed to perform job duties.
- Ability to work overtime, sometimes on different shifts, particularly in emergency conditions or for snow removal.
- Ability to maintain effective working relationships with fellow employees and the public.

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.</p> <p>While performing the duties of this job, the employee is regularly required to stand; walk; sit; talk; hear; and use hands to finger, handle, or feel. The employee is regularly required to reach with hands and arms; stoop; kneel; crouch; and crawl. The employee is occasionally required to climb or balance, and travel to other locations. The employee must frequently lift and/or move up to 60 pounds. Specific vision abilities required by this job include peripheral vision, and depth perception.</p>	<p>The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.</p> <p>While performing the duties of this job, the employee is regularly exposed to moving mechanical parts and/or heavy equipment and all types of outside weather conditions. The employee is frequently exposed to fumes or airborne particles, and grease and oil from equipment. The employee is occasionally exposed to toxic or caustic chemicals, sharp or otherwise dangerous instruments or equipment, and vibration. The noise level is usually moderate to loud.</p>
