

WATER METER SERVICEPERSON

THE OPPORTUNITY

Performs duties related to the installation and maintenance of water meters; and assists with maintaining the City's water system.

SUPERVISION RECEIVED

Works under the direction of the Superintendent of the Water and Sewer Division or Foreman.

SUPERVISION EXERCISED

None.

RESPONSIBILITIES

An employee in this position may be called upon to do any or all of the following essential duties: (These examples do not include all of the duties which the employee may be expected to perform.)

- Inspects, tests, assembles, adjusts, rebuilds, and repairs water meters.
- Maintains records of water mains, services, laterals, valves, curb boxes and meters.
- Repairs and maintains water mains and fire hydrants. Establishes and maintains necessary traffic controls; removes pavement using heavy equipment, jackhammers, or hand tools; digs to locate main; performs repair to main; replaces excavation.
- Installs water taps and meters. Checks customer services for leaks; detects and removes stopped or defective meters. Locates, replaces or repairs curb boxes. Restores surface as necessary, including ground cover. Turns water on and off.
- Flushes water mains; maintains and repairs water valves; tests and repairs water hydrants.
- Uses pickup trucks, heavy dump trucks (with or without trailers), backhoes, compressors, generators, and other equipment in the performance of required duties.
- Performs routine preventive maintenance tasks such as checking filters and fluid levels for gas and diesel-powered vehicles, hydraulic systems, small engines, and equipment as assigned.
- Reads water meters as directed, handles customer service calls related to high usage, low usage, no water, high water pressure, low water pressure, requests for meter installation and or removal.
- Performs general maintenance tasks related to buildings and grounds, including snow removal, sign replacement, debris removal, painting, sweeping, and site clean-up.
- Adheres to established safety policies and procedures and participates in safety instruction and programming.
- Accurately records activity, labor, and equipment time on time cards, in keeping with departmental policies. Records information related to vehicle usage, equipment, maintenance, work assignments and other activities.
- Performs related work as required.

PREFERRED SKILLS AND QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and ability (KSA's) required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Experience in the general repair work related to water distribution and sewer systems, including some experience involving the installation, servicing, and repair of water meters and related equipment.
- Knowledge of and ability to operate common tools and equipment used in the repair and maintenance of water and sewer mains, equipment, streets and grounds, including but not limited to air compressors, jackhammers, and generators.
- Ability to operate equipment needed to perform job duties.
- Ability to work overtime, particularly in emergency conditions.
- Ability to maintain effective working relationships with fellow employees and the public.

The employee is occasionally required to sit, climb or balance, and travel to other locations. The employee must frequently lift and/or move items of up to 60 pounds. The employee may be required to work in the same position for extended periods of time. Specific visual abilities required by this job include close vision, distance vision, peripheral vision, depth perception and ability to focus.</p>	<p>The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.</p> <p>While performing the duties of this job, the employee is regularly exposed to moving mechanical parts and/or heavy machinery equipment and all types of outside weather conditions. The employee is frequently exposed to fumes or airborne particles, grease and oil from equipment. The employee is occasionally exposed to toxic or caustic chemicals, and vibration, or required to work in a confined space requiring skills and training. The noise level is usually moderate.</p>
